# How many lawyers does it take to run a legal system?

Number of new attorneys on the decline in Valley, state David Castellon - STAFF WRITER

There was a time when young adults were anxious to become lawyers, but Janice Pearson, dean for San Joaquin College of Law in Clovis, said she recently encountered a situation that hit home on how much that has changed.

"I literally had jobs posted today for four full-time law positions," but Pearson said she knew of no recent graduates looking for work to refer to the potential employers.

"Right now, we have so many jobs for lawyers, and we have no one to send." Dan Underwood, chief deputy district attorney for Tulare County, said his office also is feeling the effects of the trend, as the early part of the year usually is when law firms are most heavily recruiting new lawyers.

Normally, by now the DA's office — which usually has at least one opening for a lawyer at any given time — would have 15 to 35 resumes submitted by job applicants, but so far this year only 10 have come in, he said. "This year, the number of applications definitely is the low-

est I've seen by far – at least by 50 percent," Underwood said. Deborah A. Coe, the newly elected president of the Fresno County

# Economist: Ignore 'miserablism,' embrace strong local economy

Last year was a good year for the economy – despite some bumps, Christopher Thornberg told a crowd gathered last Friday at the Wyndham Visalia hotel.

"And for the most part, 2018 was a very good year, on par with 2014, which was another growthsurge year," said Thornberg, founding partner of Los Angelesbased Beacon Economics, LLC, an independent economics research and consulting firm.

"Consumer spending was bet-

ter, business investment was better, exports were better, government spending was better," he said of 2018.

"But as good as the year was, we ended kind of on a down note," including the growth of housing prices slowing around year's end, along with a stock market "tantrum" resulting in a big sell off of stocks, said Thornberg, who was in Visalia for the 12th year in a row to offer Beacon's economic forecast for Tulare

think anecdotally it is believed there is a shortage. It just seems we're not getting as many applicants as we used to."

Underwood said he has heard similar comments from people at other DA offices and public-service agencies across California that hire lawyers.

The shortage seems not limited to just California.

WorldBridge Partners, LLC, an international job recruiter with clients that include law firms, posted on its website that the legal industry, like several other industries, is having trouble hiring qualified job candidates.

In fact, the problem of low enrollment in law schools in recent years has forced some to merge or shut down, with Whittier Law School in Costa Mesa's 2017 closure among them.

But the challenge of finding and hiring lawyers tends to be more acute here in the Valley and in other rural areas of the U.S.

Simply put, local lawyers contacted said, living and practicing law in Fresno, Visalia or Hanford just doesn't have the luster of working in San Francisco, Chicago, Los Angeles, New York or some other bigger cities.

Nor do law firms here generally offer pay and benefits as good as those in bigger cities, said Fresno attorney Ben Nicholson.

That put Valley law firms and public agencies at a disadvantage for hiring counsel and associates even before the lawyer shortage manifested, said Deanne Peterson, Tulare County counsel.

In fact, she said her department – like many public agencies – has been challenged in hiring lawyers looking to stay in public service, as many get the training and experience they need and then move on to more lucrative jobs, either here or in other cities, particularly the Bay Area and Los Angeles.

The problem of having enough lawyers – particularly qualified ones – comes at a time when the demand for lawyers is rising, at least here in the Valley.

"This economy is growing, and because this economy is growing, the legal community is growing," Pearson said noting that when most Valley residents leave here to attend law school, most who graduate tend to stay away.

"And we don't have enough people going to law school here locally to fill the job positions that are available."

As for why fewer people are becoming lawyers, WoodBridge Partners' website states, "That's partly because between 2008 and 2012 most law firms cut their trainee intake, which meant that there are fewer trainees qualified in disciplines such as banking, corporate and property law."

And many law firms reduced hiring during the Great Recession. That may have dissuaded some people from applying to law schools, "and we're just feeling the effects now," said Nicholson, the partner overseeing hiring at McCormick Barstow, LLP, which he

estimated to be the most active hirer of lawyers among Fresno privatepractice firms.

"Law school has become really, really expensive, and it has become more expensive over the years," and students may not want to incur such heavy student debt, Coe noted.

For her part, Pearson said the legal profession has lost some of its luster, as many young people see getting into technical fields, including videogame designing, as a better career option.

It may not have helped that California altered its bar exam from a three-day process to two days in mid 2017, she added.

Among the changes that entailed was shifting the multiple-choice section from counting as 33 percent of a score to 50 percent, said Pearson, adding that answering multiplechoice questions requires more detailed knowledge of the law, and those whose knowledge isn't so high may not score as well under the new testing criteria.

"Since that has happened, the pass rate has declined and there are fewer people to fill attorney positions," she said.

The numbers seem to bear that out, as State Bar of California data shows that the percentage of people who passed the July 2018 bar exam in California - both first timers and repeat takers – declined to 40 percent, nearly nine percentage points down from the July 2017 test.

Pearson said her law school's pass rate for people taking the test for the first time also suffered, dropping from 59 percent to 33 percent over the same percent, "so we're very concerned about it.

Underwood said his boss, Tulare County District Attorney Tim Ward, is trying to rally local interest among young people to get into the legal profession by developing programs with the College of the Sequoias in Visalia and Porterville College that introduce students to law.

While attorneys said the lawyer shortage hasn't reached a crisis stage here in the Valley, some firms have resorted to taking actions they haven't had to do before, including advertising that they have openings or reopening application periods because they didn't get enough qualified applicants the first time.

"Ultimately, we are still able to fill our hiring needs ... but we're working a lot harder to do something that used to come easier," Nicholson said.

But the worst may be over, he said, noting that hiring in the legal industry can be cyclic, "and I believe we are heading for an upswing.'

# **Rubbed the right way**

Chances are you wouldn't hire a gardener to fix your car's transmission any more than you might have a wedding planner perform your colonoscopy or have a house painter pilot a jumbo jet.

But Greg Paez isn't one to shy away from trying something different. That's why after co-owning and running a successful electronic security company going on a dozen years, the Clovis man has decided to get into a new business — opening a wellness spa in the Valley.

Stretch 360 opened in the second week of March at 334 E. Shaw Ave. in Clovis, and Paez plans to open another in Bakersfield, possibly in July, and a third in Madera not long after that.

The business offers customers massages and other therapeutic services, and a key factor is that they're provided by licensed massage therapists, as well as students in training from local massage schools.

Wisely, "I don't do any massages. I wouldn't know what I'm doing," said Paez, who started at age 18 helping install electronic security systems and four year later helped start his own security business, Clovis-based Techtronix, Inc.

Today, the company installs security systems and cameras in homes and businesses across the southern end of the Valley, though its bread and butter is installing and maintaining security cameras and alarms in school and com-

pansions and improvements of existing ones. The largest of these is the new Rio Mesa High School in Madera. The newest addition to the Chawanakee Unified School District, the \$92-million school will be built for the Tesoro Viejo project, with completion expected sometime in 2024.

Four of the top-ten projects are being developed by SCCCD, along with five more that are in the top 20. By far the most expensive and ambitious project has been the new West Fresno Campus on Church Avenue between Martin Luther King Jr. Boulevard and Walnut Avenue. At \$86.5 million, it will provide a large number of primary courses and trade classes, taking over many of the functions of the Career and Technology Center in south Fresno. SCCCD Chancellor Paul Parnell says that it's part of the district's effort to supply a growing demand for career training and education.

To this, Parnell said they are trying to make the best use of the \$485-million bond approved by voters through Measure C in 2016. Career education is in demand by SCCCD-served communities, and the district is trying to supply the growing call.

"You know, community colleges probably don't get enough credit for all of the career technical education that we're doing," Parnell said. "A lot of our

muter buses across California.

Business has been good, in part because of new requirements for school bus alarms imposed by the state and the growth of businesses in the Valley as the region has recovered from the Great Recession, Paez said, "And when that goes up, there's more business for us."

So why is a man more comfortable working with circuit boards and designing electronic systems getting into a

students want to transfer to universities, but even more of our students want an associate degree in science, or a certificate... that gives them a real opportunity to compete for jobs."

However, even with the large number of educational institutions being built or restored, by far the largest project under construction in the Central Vallev right now is not a school, but a hospital. At \$390 million, the ongoing expansion at Clovis Community Medical Center is the most expensive project in the region. Upon its projected completion in 2022, it's expected to add 144 beds to the Clovis hospital, bringing the total up to 352. Craig S. Castro, chief operating officer and executive vice president for Community Medical Centers, added that this would also be a boon to the local economy.

"About 90 percent of the sub-contractors and labor force working on the project are expected to be sourced from the local area," he said.

There's also been considerable spending on jail facilities in the Valley. According to the list, the fourth most expensive project — the West Fresno Jail expansion in Downtown Fresno — is expected to come in at \$82 million. Meanwhile, the South County Detention Facility in Porterville is being built for Tulare County at \$52 million.

business focused on relaxation?

"I opened up this business in 2007," Paez said of Techtronix. "When you open up a business, you're all gung-ho about doing it. You've got that drive and fire to succeed. Business is going good, and I love it, but I kind of wanted to have that feeling again, like I need to get my butt up and get rolling.

"I wanted to get into something I know nothing about, and I've got to make it work."

As for how he picked a business so far afield from his own, that was inspired by his security business.

"I do a lot of gyms. I see people trying to take care of themselves. They're eating right, they're working out," and Paez said he heard many of them ask about the availability of masseuses and saunas, which got him thinking about a year ago that the growing "self care" industry of people getting themselves fitter could go hand in hand with a different sort of self care - one focusing on relaxation and stress relief.

"The idea started rolling around in my head, and I said, 'you know what? I'm going to open up something that caters to this market and see if I can make it work."

Not that he knew anything about the industry, but Paez said he spent about a month researching the sort of business he envisioned — from licensing rules to the costs of massage tables and saunas — and also spoke with the staff at three local massage schools to "pick their brains."

In addition, he spoke to friends, family and clients to find out what they thought of his idea before pulling the

trigger and spending five weeks converting office space in a medical building into Stretch 360.

"I kind of went in head first. I did it really fast. I didn't want to wait to get it done" and risk losing the energy that had driven him to start the new venture, Paez said.

Of course, he hired a manager and licensed masseuses to work with clients and run the business day to day, along with some interns from the massage schools.

For his part, Paez said he has been busy as a salesman, which has included trying to get his security clients to promote Stretch 360 to their employees and offering them group rates for services.

And if you believe Paez has opened just another massage parlor, he would dispute that.

"I didn't just want the massage. I want-

In addition, cupping — which Paez plans to start offering in May — reportedly also helps with pain, inflammation, blood flow, relaxation as a type of deeptissue massage.

"There are a lot of massage places. I'm trying to create a different atmosphere," which includes offering private massage rooms and a couples massage room, as well as masseuses asking clients about their massages to find out their preference and documenting that "So next time you come in, we know what you like, what you need. We're trying to cater the massage to the individual.

"It's total body wellness from head to toe, and that's where the 360 [degrees] comes from, because it's all around," Paez said.

One of the common complaints he heard in his research was that massages were costly, so Paez said he has set his prices low, so people who might not otherwise be able to afford massages could get some pampering.

As part of his business plan, Paez intends for all his Stretch 360s to be close to health clubs, and his first is within a block of three.

All have agreed to put flyers for his business in their lobbies, and he has held raffles at the clubs for massages to drum up business. Next he plans to ask the gym managers to recommend Stretch 360 when their clients inquire about massages and saunas.

As for how his novice business is doing, Paez said, "The first two weeks was a slow start, but every week the customers are just doubling," with some becoming regulars.

County to people attending the 2019 Sequoia Regional Economic Summit put on by the Tulare County Economic Development Corp.

Those problems sparked a plethora of news reports, political debates and predictions by economic experts saying investor lost confidence in the stock market and that we surely were headed to another recession.

It's interesting about how negative the conversation about the economy had turned last year and this year, with comparisons to conditions in the stock and real estate markets a dozen years ago, before the start of the Great Recession, Thornberg said.

But the fact is, there is no way to predict that another recession — great or modest — is on the horizon, he said, noting that the Great Recession actually began in December 2007, without stock market indications it was coming, and the crash of the market and the failure Lehman Brothers Holdings, Inc. didn't occur until about nine months later.

"It is a decade past the end of

the Great Recession, but every time you turn around, every time a negative occurs in the market, its elevated to the beginning of something much worse coming," and the fact is that despite the bumps, the economy here and in the rest of the country is doing well, with low unemployment while industry is growing and interest rates remain low, Thornberg said.

Still, even the stock market likes the predictions of doom and gloom, "because it drives volatility, which drives trading, which drives commissions, which drive profits," he said.

"Bad news is good news for Wall Street."

For this year, he and Beacon researchers stated in their economic forecast report, "Yes, U.S. economic growth will slow from its pace in 2018, falling to the low 2 percent, but this is only because the sugar rush created by the fiscal stimulus tax plan of 2017 is wearing off - as was anticipated. And while there have been some weaker-than-normal numbers in certain economic data, these seem to be in line with the normal ebb and flow of economic growth rather than any bellEven though home prices have gone flat in recent months, too many pundits are trying to parallel what's happening now to the housing bubble bursting back in 2006, the forecast continues. "There is no comparison. The fundamentals of today's housing market – including affordability, vacancy rates, credit quality, household incomes and debt levels – look better than they have for twenty

As for the local outlook, Beacon's report notes that "The economic expansion has continued in Tulare County over the last year. Although the region faces some headwinds in the year to come, we expect Tulare County to continue to grow at a modest pace." states, "The outlook for 2019 is mixed. Employment levels have increased over the last year, but ongoing U.S.- China trade issues could hurt growth in crop values and output." In the big picture, signs indi-

cate Tulare County is moving up, as are communities to the north and south, Thornberg said.

"And you know this is all connected by the 99 [freeway] ... that is going to come right here into Tulare County and push this economy forward as well."

The local economy could be further helped by building more housing, as this is among the lowest-priced areas of the state for housing, making it a potential draw for people looking to escape the higher prices of Southern and coastal California, Thornberg said.

"Where people want to move is where we will see growth," he added. "Give them the housing. Give them the amenities. Create that lifestyle.

"You've got a good couple of years ahead of you. Seize the moment."

# City of Clovis adding 1,035 acres to sphere

The Fresno County Local Agency Formation Commission has approved plans to add 1,035 acres to the City of Clovis' sphere of influence.

That designation is given to land that may be urbanized and possibly annexed in the future. In this case, city officials believe the land south of Highway 168 and Shepherd Avenue, just northeast of Clovis, will eventually be developed for commercial and residential uses, generating thousands of jobs for the region.

In fact, a press release from the city said "Clovis' General Plan identified this area for significant job generation, designating over 500 acres for jobs, 225 acres of open space and 325 acres for residential uses."

It goes on to say, "The area is unique for assembling development land due to the fact that four families own approximately 85 percent of the area and share the city's vision for top-quality job and residential projects for the site.

"More steps remain to develop the project, but the property owners and city of Clovis officials are very optimistic that including the property into the city of Clovis sphere of influence is the first step to creating a regionally-significant, quality jobbased, mixed-use development."

Clovis Mayor Drew Bessinger added in the release that "this is a huge opportunity for Clovis and the region to see significant quality job growth. We have worked together as a region to make land available that can accommodate at least 10,000 jobs."

# Harris Ranch Beef Co. sold to Valley firm

Harris Farms, Inc. has sold its beef division to Hanford-based Central Valley Meat Company, Inc.

The deal, announced Tuesday, takes effect immediately. But while the two businesses will be under one company, Harris Ranch Beef Holding will continue raising, processing and selling beef to grocery stores and restaurants under the Harris Ranch brand and be run by most of its pre-sale employees and management, essentially operating separate from Central Valley Meat's operations.

One exception is that Dave Wood, chairman of Harris Ranch's beef operations, is leaving that role and staying with Harris Farms.

Despite working separately, the deal makes the combined businesses the seventh largest beef packer and processing company in the U.S., according to a joint press release.

A Harris Ranch spokeswoman said Harris Farms owner John Harris, whose parents started the business in the 1930s, hasn't disclosed why he put the meat division that started the company up for sale, nor would she disclose the selling price.

Harris Farms is one of Fresno County's largest employers, with about 2,500 workers. Company officials didn't disclose how many would become CVM employees or if any jobs would be eliminated or added as a result of the sale. Of CVM CEO Brian Coelho, John Harris said in the press release, "Brian has a proven track record of growing businesses, and under his leadership Harris Ranch Beef can continue its long and storied legacy.

"Brian and the Central Valley Meat Company team share our view that employees are our company's most valuable asset and that customers should be treated as partners, if not as family"

Harris Beef Company's website states the company generates sales of about \$400 million annually.

The sale also includes Harris Feeding Company, which supplies feed for the cattle the company raises. It operates a nearly 800-acre feedlot near Coalinga with capacity to feed up to 250,000 cattle annually.

The sale doesn't include Harris' other divisions involved in farming and raising horses. Also unaffected is Harris Farms' Hospitality Division, which includes the Harris Ranch Inn and Restaurant off Interstate 5 in the Coalinga area.

#### Lyons Magnus acquires aseptics firm

Fresno-based Lyons Magnus LLC announced its acquisition of an asepticproducts manufacturer based in Wisconsin.

Lyons Magnus, which processes ingredients for the global foodservice industry, has acquired TRU Aseptics, which specializes in liquid aseptic solutions for products including milk and creamers, plant-based beverages, cold-brew and iced coffees, teas and juices.

Founded in 2016 and headquartered in Beloit, Wisconsin, TRU Aseptics products are delivered in shelf-stable, single- and multi-service cartons, bag-in-box and bulk totes that do not require preservatives, artificial ingredients or refrigerated storage or distribution, according to its website.

The terms of the deal were not disclosed.

As part of the acquisition, Lyons Magnus plans to make "significant" investments in TRU to produce low-acid aseptic products under the marketing portfolio of Lyons TRU to Nature, according to a news release. Stacy Huels, CEO and co-founder of TRU, will join the Lyons team as the Lyons TRU to Nature president.

This acquisition was born out of two years of strategic investments by venture capital firm Paine Schwartz Partners. Paine Schwartz previously acquired an undisclosed position in Lyons Magnus in November 2017. In May 2017, Paine Schwartz also made an equity investment in Smittcamp's Wawona Packing Co.

#### Rep. Nunes files suit against McClatchy

California congressman Devin Nunes is suing a media company for \$150 million, saying it engaged in "character assassination" with a 2018 story that linked him to a yacht where prostitution allegedly took place.

A lawyer for the central California Republican filed the lawsuit against The McClatchy Co. and others in a Virginia court on Monday.

Nunes said in his complaint that McClatchy conspired to spread false and damaging information, and cited a 2018 report by The Fresno Bee newspaper in Fresno, California.

The report detailed a 2016 lawsuit filed by an employee of a winery in which Nunes has a partnership stake. The charitable arm of the winery auctioned off an outing that the employee alleged involved cocaine use and prostitution.

The news report did not claim that Nunes was on the yacht or that he was involved in the event.

The lawsuit said Nunes was not on the yacht.

Nunes has been in a running feud with The Fresno Bee. Before last year's general election, he sent out a thick mailer calling the newspaper a "propaganda machine."

#### Golden Corral ropes new markets in Fresno, Visalia

Two new commitments in the Central Valley for a nationwide restaurant chain hope to buck the trend of buffet closings with a concentrated campaign in California.

Golden Corral has announced two commitments from franchisees in Fresno and Visalia, with openings forecasted in the next 12-15 months.

While the space in Fresno is still being finalized, Van Ingram, vice president of franchise development for North Carolina-based Golden Corral, said an announcement is not far off.

Spaces for the restaurant are not small — anywhere from 10,000 to 12,000 square feet to hold up to 400 hungry people at a time.

At the same time that other buffets have closed, Golden Corral boasts "quality and fresh food" as the factor for their penetration into California.

Since 2012, the restaurant has opened 15 locations in California with one more opening this year in Moreno Valley. Two more are in the permitting process and they have signed commitments with franchisees for 13 more, including those in Fresno and Visalia. Commitments take anywhere from 12-24 months to realize.

Bac Tran signed on to be the franchisee for the Fresno area – his first with the company.

The key for Golden Corral, as Ingram puts it, is "abundance and variety." They serve American-comfort-fare, with meatloaf, a salad bar and steak always on the menu. They have anywhere from 8-10 proteins and 5-6 fresh vegetables.

Some in the Valley may have seen their television commercials but have not had the chance to visit a Golden Corral. Bakersfield is the nearest location. They've focused a lot of marketing in the state to be able to break through, and according to Ingram, the openings in California have been some of the biggest in the company. When they opened their location in Concord, it ranked volume-wise in the top-10

of openings since the company's inception in 1973.

"I think business people will see the success with our most recent opening, and I think we can replicate that," Ingram said. "That's why we're targeting the state of California."

# Solutions are emerging from seeds sown years ago



In 2000, the Irvine Foundation offered new civic DNA and significant resources to regions of California. Our assignment — figure out a new way to think and work together. Thanks to the wisdom of the Morgan Family Foundation, the experiments are still going on and we are learning from one another. The Morgans understood culture change, while seemingly glacial, compounds over time. Today, we are seeing the impact.

The new civic DNA — interdependence of economic, social and environmental issues — is backed up by social sciences, quantum physics and neuroscience. Life teaches this reality, but the obvious can be inconvenient and our ability to deny reality is well developed.

In Fresno, we assembled a team to figure out how to apply this new thinking to critical issues. We asked what shifts would have to take place for success. We identified five pillars that if tipped would ripple through the community and achieve transformational change over time.

Some were physical - land use, transportation and broadband. Three focused on people - healing, development and growth. We recognized many people had experienced severe hardship in other countries, grew up in poverty or suffered from trauma as children. Our social and health systems were overwhelmed. Academic and skill development were both hampered. Worst of all, labels, judgment and incarceration were common because most did not know the language of trauma is often behavioral. A report from the Great Valley Center underscored this reality. Not only did we lack the conditions and skills to develop a strong workforce and vibrant economy, many had accepted the situation as inevitable and unchangeable.

We put a new stake in the ground. We believed that through innovation and collaboration we could achieve community transformation and the signs of success are all around us. Downtown is revitalizing, our schools are improving, new businesses are starting, and younger leaders are embracing their responsibilities as citizens boldly and effectively. The notion that we are all in it together comes naturally to generations that grew up connected, move into alignment quickly and understand how to leverage resources.

How do we accelerate and scale? The pioneers and early adapters are already in. What about the middle — the folks that need to see to believe?

There is a powerful new book that

documents the transformational changes going on in our country – "Community Colleges as Incubators of Innovation: Unleashing Entrepreneurial Opportunities for Communities and Students." I urge you to get it, study it and inspire others to do so.

Pioneers in the movement — including the amazing Van Ton-Quinlivan, the catalyst for the dramatic changes going on in California's community colleges — lay it all out. The why, what, how and who. While every site, person and community may need to adjust the recipe, the path is clear. Success requires a new kind of leader — a civic steward who is impartial, committed and has earned the trust of positional leaders who must be willing to risk disruption and drama to align their assets behind a strategy that benefits the community.

A core belief in this work is the responsibility side of citizenship — for everyone. "It is my responsibility to figure out how to leverage my interests, skills and abilities to become useful to others." This approach turns "it's all about me" on its head. While achievement and excellence are still important, this shift in thinking transforms fragmentation, duplication and cutthroat competition into effective teams committed to mutual benefit.

The linchpin for successful communities is business engagement. Those drawn to this sector are qualitatively different, not more important, simply essential to outcomes. The more business people embrace civic responsibilities, the brighter our future will be. What does this mean specifically? Learn to teach others the high-performance habits and entrepreneurial mindset that made you successful. Provide internships. Head into the classroom to share your story. Learn to de-escalate yourself and others in order to create the psychologically safe culture people need to grow. Become a civic steward, recognizing that the success of your enterprise depends upon the success of the community. Get the book. It will inspire you to engage and recruit others.



# Despite forecast, tourism officials optimistic about foreign visitation


As the 2019 tourism season prepares to kick in, a strong turnout to America's national parks and other popular destinations is expected with a strong U.S. economy. However, there's one demographic that's expected to drop this year — foreign visitors.

According to business forecast publisher Kiplinger, foreign tourism to the U.S. is expected to grow by 2.8 percent, nearly half the 5-percent increase from last year.

The reported reason for the drop has been the strength of the American dollar, which means higher costs for foreign visitors with weaker currencies. Kiplinger further suggested that visits to the U.S. from China (Chinese visitors spend an average of \$7,000 per vacation) are also likely to decrease as their economy begins to slow down. Visits from Germany, South Korea and the Middle East are also becoming less frequent.

Despite the forecast, Steve Montalto, creative director at tourism marketing agency Visit Yosemite/Madera County, says tourism has been picking up back to its normal rate since the Ferguson Fire shut down Yosemite National Park last year — in fact, it might be better than usual.

Heavy winter rains have resulted in a good, strong snowpack, which usually means strong flocks of park goers who come to see the surging waterfalls, and the wildflowers at Yosemite are just getting ready to bloom. According Montalto, the main way that Visit Yosemite has been able to measure the number of people coming is by those stopping by the visitors'

center, and turnout has been good in the first quarter despite the government shutdown.

"Their numbers look like they're holding up pretty strong," Montalto said. "We're seeing pretty close to 50 percent of visitors coming through here are international. We haven't seen any falloff in comparison."

Likewise, Demea Metcalf, executive director for Visit Visalia, says that tourism is expected to be strong in Tulare County this year, with large numbers of visitors to Sequoia/Kings Canyon National Park. While they are still waiting for the 2018 tourist season data – which is expected to come in the first week of May - she said that in 2017, Sequoia/Kings Canyon received around 2 million visitors. Even with the government shutdown, there's been steady growth at the park.

Meanwhile, Metcalf also remains confident due in part to the projected increase in domestic visits. For example, Sequoia/Kings Canyon has seen a large amount of visitors come in from Southern California.

"Most people from California think about the California Redwoods because it's on the coast, and it's just famous," Metcalf said. "And they're still learning — even Californians are still learning — there's sequoia trees, which

are the biggest trees in the world in Sequoia Park."

The Kiplinger report added that U.S. travel is expected to top \$1 trillion with higher consumer confidence resulting in an expected 4 percent increase in travel spending.

However, the Tulare County parks receive large amounts of tourists

from overseas, especially from the U.K. and Germany. Samantha Rummage-Mathias, general manager at the Wyndham Hotel in Visalia, said she is expecting an increase in overseas visitors, and has budgeted for it. They've also completed a multimillion-dollar renovation project on the hotel. Rummage-Mathias noted that there has been an increase in foreign visitors to the park during the shoulder months of April and May, and later months like September.

Though not positive on the reasons why, Rummage-Mathias, who is herself from the U.K. and routinely visits back home, speculated that cheaper fares in the off months may have something to do with the recent phenomenon.

"So I sensed that the airline travel, the flights are a lot cheaper during those shorter months," Rummage-Mathias said. "And I think there's a lot more people taking advantage of that."

In order to aid the influx of tourists from Europe coming their way, Visit The USA, promoted as the official travel guide of the United States, has been making aggressive marketing push, including inspiration guides and advertising in the U.K., which includes extensive promotions for the sights and attractions available in California. The latest inspiration guide includes not only Sequoia, but also Visalia itself and Madera County and Yosemite.

Only time will tell as to how the national and international travel will factor in, but on all counts so far, optimism remains high.



# **Democratic socialism: The scenic route to serfdom**





In his 1944 book "The Road to Serfdom," Nobel prize-winning economist Friedrich Hayek argued that socialist economic planning resulted not just in accumulating losses of economic efficiency but "the very destruction of freedom itself."

History was kind to Hayek's worldview. The United Kingdom, Sweden, and India tested socialistic planning without sustained repression. But people in the Soviet Union, Venezuela, Cambodia and Cuba were not so lucky. Natural experiments between socialism and capitalism in East Germany and West Germany, North Korea and South Korea, and Hong Kong and China, bore out the link between economic liberty and personal freedom. Upon reunification, for example, GDP per capita in East Germany was one-third of the West German level, and the latter did not require the East's Stasi or emigration restrictions.

In criticizing socialism as it existed in the 1930s and 1940s, though, Hayek meant a government that owned and operated the means of production, controlled prices, and planned where and how production took place. Economists since have broadly agreed this type of "planned" economy is flawed, albeit recognizing every country has socialistic programs.

In 2019, "socialism" is enjoying something of a revival in American politics. A Gallup Poll last year suggested Democrat voters now think more positively of socialism than capitalism. Sen. Bernie Sanders has self-described as a "democratic socialist" since the 1960s, and Rep. Alexandria Ocasio-Cortez is a card-carrying member of the Democratic Socialists of America.

Interestingly, these modern socialists do not rhetorically echo their predecessors' definition. "To me, socialism doesn't mean state ownership of everything," Bernie Sanders has said, "...it means creating a nation ... in which all human beings have a decent standard of living.'

Lest we think socialism merely a lofty aspiration, Bhaskar Sunkara, editor of Jacobin magazine, recently claimed the key plank of socialism today is an expansive welfare state entrenching certain economic activities - such as health care and child care - as social rights. Social democracies, such as Sweden, have been held up by Ocasio-Cortez as her vision for the future.

Superficially, this seems good news. If the "socialism" label now describes social democracy - capitalist economies with highly redistributive welfare states - then the "red scare" is overplayed. We need not worry about Hayek's highway to Havana, but can debate taking the street to Stockholm. Some liberals even endorse a grand bargain with "socialists": more social welfare in exchange for a lightly regulated economy with a well-designed tax system, to generate high levels of income to redistribute.

Alas, this sanguine view is delusional. Today's socialists, while jettisoning the desire for direct government ownership, would put us on a path to Hayek's destination, albeit via the scenic route. Their vision implies far more intrusive

government than the social democratic rhetoric suggests.

Sunkara, for example, has called for converting shareholder firms into worker-owned cooperatives(something Sanders supports). This "market socialism"saw Yugoslavia's economy run into the same stagnation and inefficiency as the centrally planned variant elsewhere. For a start, the problem that cooperatives have in raising capital will require national or regional investment banks to provide funds, thus government would be picking winners and allocating resources.

Far from letting markets rip, the Green New Deal, or GND, advocates placing the economy on a war footing to reach a net zero carbon target within 30 years, including overhauling the transport sector and converting all buildings to make them energy efficient. This is the antithesis of market-led decisionmaking.

The GND's social goals do not end with fiscal transfers, either. A jobs guarantee paying a family wage would see the federal government become the world's largest employer, placing workers into its favored environmental, infrastructure and caring sectors. The GND also demands emboldened labor unions, strengthened labor market regulation, and beefed up trade rules to protect domestic workers and manufacturing. Elsewhere, socialists have extolled "free" college, breaking up financial institutions, and a \$15 minimum wage.

Far from a broad-based, pro-growth tax system to deliver the revenues for this agenda, modern socialists range from favoring direct money printing (aka Modern Monetary Theory, a view

dismissed as nonsense by every reputable economist across the spectrum) to endorsing extraordinarily high, distortionary tax rates on the rich. In fact, some want punitive tax rates to reduce inequality, even if this raises less revenue.

Where today's socialists want more generous social protections through guaranteed health care, childcare, and other benefits-in-kind, the distinction between government ownership and financing will be illusory in practice.

Once government covers the costs of a service, it sets limits on how much it pays as the major consumer, creating de facto price controls. Governments attach conditions to their spending, too, defining who can work in an industry or the standards producers must meet. These regulations create shortages in high-cost areas, necessitating subsidized provision to meet demand. Before long the industry is effectively nationalized through regulation.

Hayek's key observation was that intervention creates problems that encourage further corrective intervention, eroding freedom along the way. Today's socialists might not demand eliminating private property, nor be calling for gulags to enforce their vision. But, combined, their proposed regulatory, spending, and taxing onslaught would severely restrict freedom and undermine prosperity, just like the socialist experiments of old.

# Sacramento working \$6.2B in new taxes, fees

As of the deadline for introducing legislation, California lawmakers proposed more than \$6.2 billion a year in higher taxes and fees, the nonpartisan California Tax Foundation reported last week. This figure will grow substantially as fiscal estimates are prepared for recently amended measures, the foundation added.

A \$4 billion-per-year tax on sweetened beverages (AB 138) is the largest tax documented in the Tax and Fee Report, which is based on higher taxes, fees, assessments and charges proposed from the first day of the legislative

session (December 3, 2018) through the bill introduction deadline (February 22, 2019). During this period, lawmakers introduced 2.721 bills

and constitutional amendments, includ- totaling \$200 million in new annual taxes

Another bill (SB 522) proposes an asyet-unspecified sales tax on services that likely would be much higher than the soda tax. The estimated cost of SB 522 was not included in the report's cumulative total because it will vary dramatically based on what provisions are amended into the bill. A similar proposal from the prior legislative session was estimated to cost taxpayers as much as \$49 billion per year.

Several taxes and fees were amended into bills after the period covered by this report, and will be included in the second-



quarter update. These include a corporation income tax increase on businesses based on chief executive officers' compensation (SB 37); a proposed estate tax that the author says would cost taxpayers \$500 million to \$1 billion per year (SB 378); a proposed repeal of tax exemptions including those for food, medicine and water, and repeal of tax incentives including the research-and-development tax credit, water's-edge elections and others, costing taxpayers approximately \$20 billion per year (SB 468); and a proposal for vari-

ous tax-like "fees" on water users that does not yet have a fiscal impact estimate (AB 217). Last year, Gov-

ernor Jerry Brown signed legislation

ing 40 that contained higher taxes or fees. and fees. In January, Governor Gavin Newsom proposed a \$209 billion state budget that includes almost \$20 billion in reserve accounts, and calls for a \$7.6 billion increase in spending over the enacted 2018-19 budget.
