It was a congratulatory environment Tuesday evening at Fresno's Elbow Room as The Business Journal honored the companies emerging as winners of our annual reader voting contest.

An invite-only crowd of just under 100 people representing winners and finalists gathered to find out who our readers crowned the cream of the crop in our eighth-annual event. From a humble start of 22,000 votes in the first year of competition, nearly 151,000 individual votes were cast at thebusinessjournal.com from

Sept. 1 to Oct. 31 for the 2021 Best of Central Valley Business Readers Choice Awards. That also represents an increase of 16% from last year.

Website visitors chose their favorite local businesses in 35 categories. While voters were required to vote in a minimum of 25 categories for a ballot to count, no categories were skipped in the 4,313 ballots cast. Best Politician on Business Issues Rep. Devin Nunes

Republican Rep. Devin Nunes has been selected once again by Business Journal readers as the Best Politician on Business Issues.

This also may be his last year of eligibility for the title as Nunes announced this week his intention to leave Congress after 19 years to become CEO of former Pres. Donald Trump's new media company, Truth Social. He begins that job early next year.

The former dairy farmer joined Congress in 2003 and campaigned on a platform of tax reform and water for Central Valley farms, cities and towns.

Nunes also served as chair of the House Intelligence committee from 2015 to 2019. His national profile expanded greatly as an ally of Pres. Trump.





One d effectively undo a 1975 law imits damages for "pain and ring" in medical malpractice , while another would place a limit on the fees that personal y attorneys can claim.

1975 law, entitled the Medical y Compensation Reform Act RA) and signed by Jerry Brown ng his first year as governor, s non-economic damages alpractice to \$250,000. Its ige was not only a big win edical providers and their ers but the opening salvo of var.

The attorneys not only have tried - very unsuccessfully so far - to repeal or modify MICRA but have sought to expand opportunities to sue and collect damages and fees, such as allowing them to intervene in cases that ordinarily would be handled by local or state legal authorities.

Business groups and insurers, meanwhile, have not only attempted to blunt the attorneys' expansive ambition but to carry the MICRA model of damage limits into other potential injury cases.

In 1987, 12 years after MICRA was enacted, the speaker of the state Assembly, Willie Brown, mediated extensive negotiations between the warring factions on a truce, culminating in the infamous "napkin deal" worked out in Frank Fat's restaurant near the Capitol with Brown hopping from table to table.

Quickly ratified by the Legislature, it gave lobbyists for every interest involved something to take back to their clients, including a slight modification of MICRA and new

protections for the tobacco industry from lawsuits by smokers for cancer and other illnesses.

The napkin deal truce lasted for a few years, but tort wars resumed in the 1990s and have been waged ever since on specific issues, including several unsuccessful efforts to change MICRA. One subset of the conflict, involving roughly the same interests, has been perennial jousting over workers' compensation, the employerfinanced, multi-billion-dollar system that covers job-related injuries and illnesses.

A ballot measure that would indirectly but effectively repeal MICRA is already qualified for the 2022 ballot even though the anti-MICRA coalition has failed repeatedly in the past to undo what the Legislature and Jerry Brown wrought 46 years ago.

Meanwhile, the Civil Justice Association of California, an umbrella organization of business and insurance interests, has unveiled its own initiative measure that would limit lawyers' contingency fees in personal injury cases to 20% of monetary judgments, sharply lower than the traditional one-third or more. The goal, obviously, is to make attorneys less willing to take on cases. The stage is set, therefore, for the competing factions to spend tens of millions of dollars to persuade voters, which would be a tiny fraction of the many billions of dollars at stake in the outcome. And regardless of what happens next

year, the immense stakes mean tort wars will continue to rage indefinitely.




